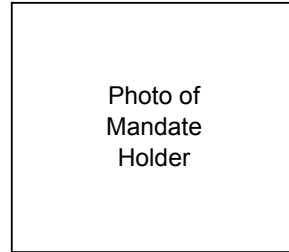



**Terms & Conditions:**

1. I hereby declare that I am a non-resident Bangladeshi of Bangladeshi origin. I understand that the above account will be opened on the basis of the statements / declarations made by me and I also agree that any of the statements/ declarations made herein is found to be not correct is material particulars; you are not bound to pay any interest on the deposit made by me. The account will be put into use for bonafide transactions not involving any violation of the provisions of any Government/ Exchange regulations.
2. I hereby authorize the mandate holder
  - a) to draw cheques on the said account
  - b) to deposit and /or discount cheques and other instruments in the said account and for this purpose to endorse on my behalf cheques, drafts, pay orders and other instruments payable to me
  - c) to make deposits from balance available in the account in my names and renew such deposits for such periods as may be given in writing by the mandate holder
  - d) to certify balance confirmation statement of accounts issued by the Bank in respect of the said account
  - e) to give instructions in writing involving debits to the said accounts, transfers there from, etc
  - f) to make withdrawals for investments in Bangladesh where necessary permission from Bangladesh Bank has been obtained by me.
  - g) to use the ATM card issued in respect of the mentioned account.
3. I authorize BRAC Bank to issue a BRAC Bank ATM card and a cheque book to the mandate holder. I and the mandate holder acknowledge that the issue and usage of the card is governed by the terms and conditions as in force from time to time and agree to be bound by the same. I and the mandate holder acknowledge that it is my responsibility to obtain a copy of and read the same. I and the mandate holder accept that the terms and conditions are liable to be amended by BRAC Bank Limited from time to time. I further unconditionally and irrevocably authorize BRAC Bank Limited to debit my account annually with an amount equivalent to the fee and charges for the use of the said ATM card if any.
4. I declare that as per exchange control guide lines issued by Bangladesh Bank:
  - a) the mandate holder can exercise the authority conferred by this letter to withdraw for local payments only and make investment in Bangladesh where I hold general permission or have obtained specific permissions from Bangladesh Bank.
  - b) the mandate facility permits the mandate holder to remit funds in foreign currency to the account holder(s)
5. I there by undertake that I and my mandate holder shall comply with the provisions of the Exchange Control Guidelines issued by Bangladesh Bank and the Foreign Exchange Act, 1947 and all regulations thereof, including the Foreign Exchange Guideline, I hereby undertake I have made known to the mandate holders the specific uses of the ATM Card as per the said Regulations and Guidelines. I hereby undertake to indemnify BRAC Bank against any loss, damage, claim, action, proceedings, costs, charges fraudulent activities and expenses that may be suffered or incurred by BRAC Bank on account for any activity undertaken by the mandate holder by the use of the ATM card.
6. The specimen signature of the mandate who has been authorized to operate upon the account is given below. The signature has been duly attested and verified by me.
7. This authority shall continue in force until I expressly revoke it by a notice in writing delivered to you
